CONSULT JUDGING PROGRAM for time of judging.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. THEY WILL ADHERE AS CLOSELY AS POSSIBLE TO THE JUDGING SCHEDULE. The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged.

DOGS NOT REQUIRED for further judging will be excused.

CASH PRIZES will be paid in the ring to the person showing the dog, who will be considered as the owner or authorized agent. Claims for prize money must be made in the ring before the judging of that class is over, and the Trial Secretary advised at once. The Show-giving Club disclaims any liability for cash prizes after the judging is over.

DOGS ARE NOT ALLOWED IN CAFETERIA.

WE ASK EVERYONE'S COOPERATION in keeping the grounds as clean as possible.

PRIVATE EXERCISE PENS will not be allowed.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
