Directions to Show Site

From the West - Take Rt 80 East to Exit 34 (Rt 15 North). Rt 15 North to Rt 517, Sparta-Franklin exit. Turn right at the end of the exit ramp onto Rt 517 North. Go 4.8 miles. Turn left onto Munsonhurst Road. Show site is on the left.

From the East - Take Rt 80 West local to Exit 53 to Rt. 23 North. Go approx. 25 miles to Rt. 517. Make left onto Rt 517 South (towards Sparta) and an immediate right onto Munsonhurst Road. Show site is on the left.

From the South - Take Garden State Parkway to Rt 80 West (local) (Exit 159) or 46 West (Exit 157), follow directions from the East.

From the North - Take Rt. 94 West to Rt. 23 South, turn right onto Rt. 517 South (towards Sparta) and an immediate right onto Munsonhurst Road. Show site is on the left.

NOTICE TO EXHIBITORS

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the Show Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the breed is over.

EXHIBITORS AND HANDLERS will be responsible for clean conditions in and around their crates and grooming area.

Admission Free.

No Space will be provided for unentered dogs.

Due to the number of crates and grooming tables, chairs will not be allowed in the grooming area.

Private Exercise pens will not be permitted inside the building.

No Chalking will be permitted inside the building.

Exhibitors must be governed by any rules or regulations of civil authorities, building and parking restrictions.

Vehicles parked contrary to regulations will be subject to towing at owner's expense.
