A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: AMERICAN WATER SPANIEL; BYKIN SPANIEL; ENGLISH SPRINGER SPANIEL; FIELD SPANIEL; NS DUCK TOLLING RETRIEVER; WELSH SPRINGER SPANIEL; GRAND BASSET GRIFFON VENDEEN; WHIPPET; GERMAN PINSCHER; STANDARD SCHNAUZERS; AMERICAN STAFFORDSHIRE; IRISH TERRIERS; MINI BULL TERRIER (Ground/Table); SOFT COATED WHEATEN TERRIER; STAFFORDSHIRE BULL TERRIER; FINNISH SPITZ; AUSTRALIAN CATTLE DOG; ENTLEBUCHER MOUNTAIN DOG; FINNISH LAPPHUND; ICELANDIC SHEEPDOGS; MUDI (or Table); NORWEGIAN BUHUND; POLISH LOWLAND SHEEPDOG; PULI (or Table); SPANISH WATER DOG; BASSET FAUVE DE BRETAGNE (Misc.); NORRBOTTENSPETS (Misc.);

#### SCHEDULE OF POINTS FOR DIVISION 2 — EFFECTIVE MAY 15, 2024

#### Division 2 is comprised of: Delaware, New Jersey, New York, Pennsylvania

The Points towards a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of **both** sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of *its own sex* that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

NOTICE: An agent is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner of an exhibit to be handler of, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications which are available at the superintendent's office.

## Point Schedules for Dogs and Bitches of each breed can be found with their respective listings in the catalog.

#### RAMP INFO

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: AMERICAN WATER SPANIEL; BOYKIN SPANIEL; ENGLISH SPRINGER SPANIEL; FIELD SPANIEL; NS DUCK TOLLING RETRIEVER; WELSH SPRINGER SPANIEL; GRAND BASSET GRIFFON VENDEEN; WHIPPET; GERMAN PINSCHER; STANDARD SCHNAUZERS; AMERICAN STAFFORDSHIRE; IRISH TERRIERS; MINIBULL TERRIER (Ground/Table); SOFT COATED WHEATENTERRIER; STAFFORDSHIRE BULL TERRIER; FINNISH SPITZ; AUSTRALIAN CATTLE DOG; ENTLEBUCHER MOUNTAINDOG; FINNISH LAPPHUND; ICELANDIC SHEEPDOGS; MUDI (or Table); NORWEGIAN BUHUND; POLISH LOWLAND SHEEPDOG; PULI (or Table); SPANISH WATER DOG; BASSET FAUVE DE BRETAGNE (Misc.); NORRBOTTENSPETS (Misc.);

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions. Ramps can be used in emergency situation to judge any breed.

In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breed. (6/24/24)

- NOVICE JUNIOR CLASS: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places with competition present in a Novice Class at a licensed or member show.
- NOVICE INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **NOVICE SENIOR CLASS:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **OPEN JUNIOR CLASS**: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Showmanship Class at a licensed or member show.
- OPEN INTERMEDIATE CLASS: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.
- OPEN SENIOR CLASS: For Boys and Girls who are least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Showmanship Class at a licensed or member show.
- MASTER CLASS: This Class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed.
