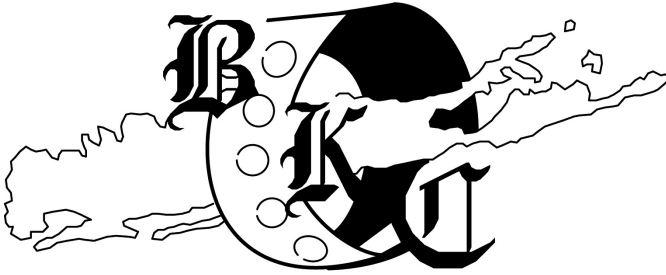

ROUTES TO THE SHOW SITE

From East: Take the Long Island Expressway to exit 68 north (William Floyd Pkwy.). Turn left onto Longwood Rd. At end of Longwood Rd. turn left; entrance is immediately to your right.

From West: Long Island Expressway (495) to exit 66 north (Sills Rd.); turn left onto E. Patchogue Yaphank Rd./Sills Rd. Slight left to stay on E. Patchogue Yaphank Rd./Sills Rd. Continue onto Coram-Yaphank/Yaphank Middle Island Rd. Park is on your left.

Hiking, Camping, Mountain Biking, Bridle Paths, Picnicking

This 320 acre site is situated along the headwaters of the Carmans River. Facilities include campsites for individuals, youth group camping and club camping (10 or more units) and family camping, including 10 sites with water and electric hookups. Picnic sites and the George Broome Memorial Activity Building are also available. Adjacent to Cathedral Pines Park is Prosser Pines Nature Preserve, which features a majestic stand of white pines planed in 1812. Prosser Pines is a popular site for hikers and photographers.

Cathedral Pines County Park will be charging a \$9.00 entrance fee into the park. For those exhibitors that do not live in Suffolk County please bring your show entry to prove you are going to the show. Otherwise the park will charge you a \$15.00 entrance fee for non-residence.

*** NOTICE TO EXHIBITORS ***

DOGS MAY ARRIVE any time prior to their scheduled time of judging. DOGS NOT REQUIRED for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring.

CLASS CASH PRIZES will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that class is over, and the Show Secretary to be advised at once. The Show Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the class is over.

THE SHOW COMMITTEE/SUPERINTENDENT will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.
