**NOTICE REGARDING TROPHIES:** All trophies will be available at the trophy table and must be claimed prior to the awarding of Best in Show unless otherwise indicated. Any trophy which remains unclaimed by the time Best in Show is awarded will be forfeited. No trophy will be mailed.

**ROSETTES FOR SUPPORTED ENTRIES:** Delaware Valley Hound Association and its members are proud to offer Rosettes for the following awards for all of our Supported Breeds: *Best of Breed or Variety, Best Of Winners, Best Opposite Sex, Winners Dog, Winners Bitch, Owner-Handled Best of Breed.* Please refer to **PRIZES** for other rosettes that may be offered beyond the placements noted here.

**ROSETTES FOR NEW TITLE HOLDERS:** A rosette will be awarded to each dog that finished their championship or title at this show. Please pick up the rosette at the Club table.

**GROOMING SPACES:** The grooming areas open to exhibitors not earlier than 2PM on Tuesday. Breeds exhibiting in Rings 10-12 should use grooming space in Hall D. All other conformation crating space is in Hall A. Electricity is free and available in all areas within range of a 100-foot extension cord. Reserved preferred spaces in Halls A and D are available by pre-registration. Spaces may be reserved without limit on a first come, first served basis. Each 5 x 6 ft space is \$40 by online order or \$45 by mail order for the entire cluster. The fee for one space per person is waived for breeds conducting **SPECIALTIES ONLY**. Reservations made through VFKC. See Winter Blast PL for more information. [www.raudog.co/WinterBlast24PL](http://www.raudog.co/WinterBlast24PL). EVEN IF NO FEE IS DUE, A FORM MUST BE SENT so that a space will be reserved in the specialty section for that breed. The remaining free space is available on a first come, first served basis. No reserving of space in the free section will be permitted. Stacking of crates is encouraged.

**OVERNIGHT CRATING:** Dogs may be left overnight on Tuesday through Saturday. On the crate of each dog staying overnight must be placed a label or tag bearing the dog's call name, owner's or handler's name, and owner's or handler's mobile phone number. **The hall will be locked not later than 10PM each night and unlocked at 6AM the following morning.** Though a security guard will be present, DVHA, BCKC, SJKC, and VFKC recommend against the use of overnight crating. DVHA, BCKC, SJKC, and VFKC will not be responsible for any injury or loss that occurs during or results from the use of overnight crating. Such use is entirely at the owner's risk.

**RV PARKING** is \$120 by online order or \$130 by mail order REGARDLESS OF DURATION and by pre-registration only. Failure to pre-register will result in an additional \$50 LATE FEE or refusal of admission to the RV parking area. Reservations made through VFKC. See Winter Blast PL for more information.

[www.raudog.co/WinterBlast24PL](http://www.raudog.co/WinterBlast24PL). **RV parking is available not earlier than noon Tuesday; all rigs must depart by 7PM Sunday.** Absolutely no hook-ups available, and no electric lines may be laid across roads. Fire lanes must be kept clear. No parking spaces may be reserved using cones. Exercise pens must use wood shavings and be cleaned up before departure. A dumpster is available for waste collection. Failure to obey the instructions of parking officials will result in forfeiture of parking privileges and may result in further penalty per the Event Committee.

**RESERVED PARKING** outside of the RV and officials areas **does not exist**. Any object used to block a parking space may be freely discarded.

**BATHING STATIONS** are NOT available at the venue.





# AKC National Owner-Handled Series Competition

(Remember to check the box near the bottom of the entry form)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

**Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.**

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge’s book, steward’s book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers’ organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

*\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

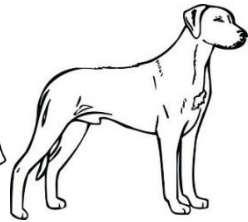

### Non-Regular Classes For All Breeds

Veteran Classes: Classes for Dogs and Bitches 7 years or older. Will compete for Best of Breed / Variety and thus cannot be spayed/neutered.

### Best of Breed (Variety) Competition

All Regular Classes are divided by sex and are offered for all breeds or varieties of breeds unless otherwise noted. Where classes are further divided by color, weight, or other breed characteristics, it is so indicated, and the class division MUST be indicated on the entry form.

**\*Amateur-Owner-Handler** - For dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog and is limited to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler

**\*\*Bred-By Exhibitor Class eligibility:** All dogs entered in the Bred-by Exhibitor Class must be individually registered with the AKC. The Person handling the dog must be a breeder of record of the dog and an owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.

## NOTICE:

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on a ramp through all levels of competition: Basset Fauve de Bretagne, Grand Basset Griffon Vendeen and Norrbottenspets, Whippets.

The following breeds must be judged on a ramp through all levels of competition: Basset Hounds and Cirneco dell'Etnas.

The following breeds must be judged on a table through all levels of competition: Basenji, Beagles (all), Petit Basset Griffon Vendeen, Dachshunds (all), Portuguese Podengo Pequeno.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4–6 Month Beginner Puppy Competition (*where offered*), the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situation to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

## ATTENTION OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS:

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1. The dog show rules are posted on the AKC Web site at: <http://images.akc.org/pdf/rulebooks/RREGS3.pdf>

Most important to note are the following:

- Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred-By Exhibitor class.
- Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, *regardless of whether the dog earned any points or awards*. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. **ENTRY FEE:** \$37.00 for the first entry of each dog except Bred-By Exhibitor Classes which are \$32.00 (including 50¢ AKC Recording Fee & AKC Event Service Fee of \$3.00 for the first entry of a dog & a \$3.50 service fee each additional entry of the same dog in an event).

**OPENING DATE** for entries will be 9:00 AM, Tuesday, October 22<sup>nd</sup>, 2024

**LIMITED SHOW** entries will be limited to 240 dogs total.

**CLOSING DATE** for entries will be 12:00 PM (Noon), Wednesday, November 20<sup>th</sup>, 2024 (at Superintendent's Office), or when the numerical limit set above has been reached, after which entries cannot be accepted, cancelled or substituted except as provided for in Chapter 14, Section 6 of the Dog Show Rules.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
