## Routes to the Events

**From all points East/West:** Take I-84 to Exit 19 (Route 312) towards Carmel, NY. Continue on Route 312 to traffic light at Route 52. Right at light to Route 6. Right on Route 6 to traffic light at Route 301. Left on Route 301 and continue over causeway across reservoir. Immediately at the end of the causeway make a right on Gypsy Trail Rd. and continue to park entrance on the right.

**From all points North/South-Taconic State Parkway:** Take Peekskill Hollow Rd. Exit right at the bottom of the ramp onto Peekskill Hollow Rd. Continue to the end and turn right on Route 301. Continue on Route 301 until you see the causeway over the reservoir (slight curve to the right). Just before the causeway, Gypsy Trail Rd. will be on the left. Take Gypsy Trail Rd. to entrance to park on the right.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. #### RAMP INFO

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required. The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

The following breeds must be judged on a Ramp through all levels of conformation competition: Clumber Spaniels, Sussex Spaniels, Basset Hounds, Cirnechi dell'Etna, Kerry Blue Terriers, Bulldogs, Chinese Shar-Pei, Chow Chows, Keeshonden. Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition. The full policy and list of Table and Ramp eligible/required breeds is available on the AKC website at:

Judges may request the ramp to judge any breed in emergency situations; if granted, unless the use of a ramp has been indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund. Junior Showmanship judges should follow the above.

**NOVICE INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE SENIOR CLASS:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS:** For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Showmanship Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Showmanship Class at a licensed or member show.

**MASTER CLASS:** This Class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to entry the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.
